The BIOFUELS AREA in CARTIF works on the promotion of the use of biomass as an energy resource, mainly focused on agro-forest and wood manufacturing processes, and their application to energy production for public and private buildings. The main research areas in which the department is working are:

- Biomass resources quantifying in certain areas, with the objective to study the possibilities of producing thermal energy and electricity with residues.
- Implementation of biomass installation projects in the real life.
- Biomass residues pre-treatment and densifying.

Proposed contribution to the selected Sub-Priority:

Reducing CO2 emissions in coal-fired power stations is more and more demanded and this can be done replacing a percentage of coal by biomass. The co-firing of biomass and coal has large outlooks of development and the Biofuels Area of Cartif Foundation has experience and knowledge in this field.

We owns equipment to performance co-firing tests at laboratory scale, as well as equipment for measuring fuels behaviour and combustion emissions characterisation. We are interested in using them in cooperation projects.
